ADMINISTRATIVE ORDER NO. 10.401-1/24*

IN RE: ASSIGNMENT O	F CIVIL	TRAFFIC IN	NFRACTIONS

The efficient administration of the Traffic Division requires a uniform policy concerning assignment of traffic infractions to the various courthouses within the county.

NOW, THEREFORE, pursuant to the authority conferred by Florida Rule of Judicial Administration 2.215, it is **ORDERED** as follows:

- 1. All traffic infractions will be assigned to the courthouse facility assigned to the specific law enforcement agency as set forth below, with the exception of red light camera citations issued pursuant to F. S. 316.0083 and parking tickets, which may be scheduled in any county courthouse facility regardless of which agency issued the citation.
- 2. Citations issued by the following departments will be assigned to the Main Judicial Center:

 - b. Lake Clarke Shores
 - c. Town of Palm Beach
 - d. Palm Springs
 - e. Florida Highway Patrol, Troop L (only those citations that require a hearing before a Judge)

 - (2) District 8 (City of Wellington)
 - (3) District 9 (City of Royal Palm Beach)

 - (5) District 14 (City of Lake Worth)
 - (6) District 15 (unincorporated Loxahatchee area)
 - (7) District 16 (City of Greenacres)
 - (8) District 17 (City of Loxahatchee Groves)
 - (9) District 18 (City of Westlake).

- 8. Cases that are scheduled to appear before a county court criminal judge will be assigned in accordance with Administrative Order 4.603- (as amended).
