IN RE: UNKNOWN PARTY IN POSSESSION
IN ACTIONS FOR POSSESSION

The Legislature has modified the requirements for service of process for unknown parties in possession in actions governed by Florida Statute sections 82.03, 83.21, 83.59, and 723.061. Section 48.184(3), Florida Statues (2022) now provides that "[i]f the name of the occupant becomes known to the plaintiff through the return of service or otherwise, without notice or hearing thereon, all subsequent proceedings must be conducted under the true name of such occupant and all prior proceedings are deemed amended accordingly." Directions to the Clerk are needed so that the caption of the case can be updated to implement the requirements of this statute.

**NOW, THEREFORE**, pursuant to the authority conferred by Florida Rule of General Practice and Judicial Administration 2.215, it is **ORDERED** as follows:

- 1. Effective January 2, 2023, upon the filing of a "Notice of Identity of Unknown Party in Possession and Directions to Clerk to Update Party Information," the Clerk shall update the caption in actions governed by section 82.03, 83.21, 83.59, and 723.061 to reflect the now-known identity of any previously unknown party in possession.
- 2. The attached "Notice of Identity of Unknown Party in Possession and Directions to Clerk to Update Party Information" is hereby adopted.
