Course Descriptions:

Cyber Safety: *Youth will learn how to be a responsible digital citizen. The three focuses of this clinic are how to stay safe from online predators, how online behavior can have real-life consequences, and cyberbullying.*

Jobs 101: *Youth will learn valuable information relating to obtaining and maintaining a job. This clinic covers commonly asked questions at a job interview and how to answer them, what to wear to a job interview, how to address questions pertaining to a criminal record as well as mock interviews.*

Know Your Record: *Youth will learn about the juvenile justice system and covers topics such as the difference between conviction and adjudication, expunction and sealing, and different types of court proceedings. Youth will discuss how to answer questions about a criminal record for job applications, college applications, and the military.*

Life Skills: *(new in 2025) Youth will learn important information to help develop independent living skills. This includes, but is not limited to: how to open a bank account, how to schedule a doctor's appointment, how to grocery shop, and how to obtain a driver's license/identification card.*

Unlock Your Potential: *Encountering a setback does not mean it is time to give up! Youth will learn how to face setbacks head on and use them as motivation to keep going. Youth also will learn the importance of goal setting and how to reach those goals.*
