What is Child Parent Psychotherapy (CPP)?

- Child Parent Psychotherapy is a relationship based treatment for parents and young children
- The central goal of CPP is to support and strengthen the parent-child relationship
- CPP helps the parent and the child feel safe with each other
- In CPP sessions, the clinician helps the parents learn to understand their child's signals

What is a Guardian Ad Litem?

- A Guardian Ad Litem also known as a GAL is an individual assigned to your case to be an advocate for the needs of your child
- GALs visit children at daycare and at home as well as attend team meetings and court hearings

Early Childhood Court assists families in the dependency system with infants and toddlers (between the ages 0-5).

You and your child will be working closely with a team of individuals. The goal is to enhance the parent-child relationship during this difficult time and to focus on the completion of your case plan services so that permanency is achieved timely and safely.

Being involved in Early Childhood Court is a voluntary option for you. The Judge has to know that the parent(s) want to participate before being accepted. Your commitment is very important to your success.
