CHILD CUSTODY AND VISITATION REQUIREMENTS (Parent in Florida)

NEITHER PARENT SHALL CONCEAL THE WHEREABOUTS OF ANY CHILD OF THE PARTIES, AND EACH PARENT WILL KEEP THE OTHER ADVISED AT ALL TIMES OF THE RESIDENTIAL ADDRESS AND PHONE NUMBERS WHERE THE CHILDREN WILL BE STAYING WHILE IN THE CUSTODY OF EITHER PARENT. EACH PARENT SHALL NOTIFY THE OTHER IMMEDIATELY (NO LATER THAN 3 HOURS) OF ANY EMERGENCY PERTAINING TO ANY CHILD OF THE PARTIES.

"REASONABLE" VISITATION WITH ANY CHILD OF THE PARTIES SHALL TAKE PLACE AT SUCH TIME AND PLACE AS THE PARTIES MAY AGREE. IF THE PARTIES CANNOT REACH AN AGREEMENT AS TO DETAILS OF VISITATION, THE VISITATION SCHEDULE SET FORTH BELOW SHALL APPLY.

- 1. <u>WEEKENDS</u>: Non-custodial parent bi-weekly (every other weekend) from 5:00 PM Friday to 7:00 PM the following Sunday.
- 2. <u>WEEKDAYS</u>: Non-custodial parent every Wednesday from 5:00 PM to 8:00 PM.

3. HOLIDAYS:

- A. Winter Vacation for children enrolled in school Non-custodial parent:

 <u>Even years</u> from 5:00 PM on the Friday beginning school vacation, to 7:00 PM on December 25.

 <u>Odd years</u> from 7:00 PM December 25, to 2:00 PM on the Sunday prior to resumption of school.
- B. Winter vacation for children not enrolled in school Non-custodial parent: every year, from 12:00 Noon to 7:00 PM, December 25.
- C. Spring Vacation for children enrolled in school Non-custodial parent: entire Spring Vacation annually, from 5:00 PM on the last day of school, to 2:00 PM on the Sunday prior to the resumption of school.
- D. Thanksgiving Non-custodial parent:
 - Odd years from 5:00 PM on the Wednesday before Thanksgiving to 7:00 PM, the Friday following Thanksgiving.
 - Even years from 7:00 PM the Friday following Thanksgiving day to 2:00 PM the following Sunday.
- E. Mother's Day/Father's Day: To be spent with the parent being honored by the holiday in question from 10:00 AM to 7:00 PM.
- F. Birthdays: The child shall celebrate his or her birthday in the home of the custodial parent, unless the birthday falls on a regularly-scheduled visitation date with the non-custodial parent.
- G. Non-specified Holidays: Should the parents jointly recognize a holiday not specifically mentioned in this Order, each parent shall cooperate with the other in providing visitation with the non-custodial parent for the entire holiday on even-numbered years, and in working out beginning and ending times for such visitation.

Child Custody and Visitation Requirements (Parent in Florida) continued

4. <u>VACATION FOR CHILD NOT ENROLLED IN SCHOOL</u>: Non-custodial parent- one month each year, to coincide with the non-custodial parent's vacation from his or her employment. Notice of the dates of such vacation period shall be given to the custodial parent no less than 60 days before the one-month visitation begins. The vacation visitation will last 30 consecutive days, and may not be "split" into lesser blocks of time unless both parties agree.

5. SUMMER VACATION FOR CHILD ENROLLED IN SCHOOL:

Non-custodial parent: from 5:00 PM on the second Friday after the end of the school year, to 5:00 PM on the eighth Sunday following the conclusion of the school year.

Custodial parent - one weekend visitation during the child's summer vacation with the non-custodial parent, from 5:00 PM on the fifth Friday after conclusion of the school year, to 7:00 PM on the following Sunday.

- A. Summer School: If the child is required to attend Summer School to pass to the next grade, it must be attended, and the above-described Summer Vacation Visitation Schedule does not apply. Weekend Visitation as set forth in Paragraph of 1 of this Order will apply during Summer School. The non-custodial parent's summer vacation visitation will commence at 5:00 PM on the Friday following the conclusion of Summer School, and last to 7:00 PM on the seventh Sunday following the conclusion of Summer School or 7:00 PM on the Sunday immediately prior to commencement of the new school year, whichever comes first.
- 6. <u>WAITING</u>: The child and custodial parent are required to wait no more than 30 minutes for the non-custodial parent to pick up the child to begin any visitation. A parent who is late (over 30 minutes) in picking up a child from the other parent forfeits his or her right of visitation for that period.
- 7. <u>CANCELLATIONS</u>: Cancellation of visitation by either parent can only occur with consent of both parties. The request for cancellation must be given to the other party no later than 5:00 PM on the Wednesday before the visitation begins; for summer and spring vacations, the request must be made no less than 30 days before the vacation is scheduled to begin. If the cancellation is not agreed to by both parties, the parent seeking to cancel visitation must arrange and pay for baby sitting, child-care, or other appropriate supervision of the child for the visitation period. Failure to properly provide for care and supervision of the child under such circumstances may result in loss of future visitation rights.
- 8. <u>CONFLICTS</u>: Regular Weekend, Weekday, and Summer Vacation visitation shall be had in coordination with the Holiday Visitation Schedule set out in this Order. Should there be any conflict between the regularly-scheduled visitations and the Holiday Visitation, the Holiday Visitation Schedule will control.

CHILD CUSTODY AND VISITATION REQUIREMENTS (Out-of-State Parent)

NEITHER PARENT SHALL CONCEAL THE WHEREABOUTS OF ANY CHILD OF THE PARTIES, AND EACH PARENT WILL KEEP THE OTHER ADVISED AT ALL TIMES OF THE RESIDENTIAL ADDRESS AND PHONE NUMBERS WHERE THE CHILDREN WILL BE STAYING WHILE IN THE CUSTODY OF EITHER PARENT. EACH PARENT SHALL NOTIFY THE OTHER IMMEDIATELY (NO LATER THAN 3 HOURS) OF ANY EMERGENCY PERTAINING TO ANY CHILD OF THE PARTIES.

"REASONABLE" VISITATION WITH ANY CHILD OF THE PARTIES SHALL TAKE PLACE AT SUCH TIME AND PLACE AS THE PARTIES MAY AGREE. IF THE PARTIES CANNOT REACH AN AGREEMENT AS TO DETAILS OF VISITATION, THE VISITATION SCHEDULE SET FORTH BELOW SHALL APPLY.

1. <u>WEEKENDS</u>: Non-custodial parent - The 1st weekend of every month from 5:00 PM Friday to 7:00 PM the following Sunday.

2. HOLIDAYS:

A. Winter Vacation for children enrolled in school - Non-custodial parent:

<u>Even years</u> - from 5:00 PM on the Friday beginning school vacation, to 2:00 PM on the Sunday prior to resumption of school attendance.

Odd years - from 7:00 PM Dec. 25 to 7:00 PM Dec. 26.

B. Winter vacation for children not enrolled in school - Non-custodial parent:

Even years - from 12:00 Noon Dec. 23, to 7:00 PM, December 29.

Odd years - from 7:00 PM Dec. 25 to 7:00 PM Dec. 26.

- C. Spring Vacation for children enrolled in school Non-custodial parent: entire Spring Vacation annually, from 5:00 PM on the last day of school, to 2:00 PM on the Sunday prior to the resumption of school.
- D. Thanksgiving Non-custodial parent:

Odd years - from 5:00 PM on the Wednesday before Thanksgiving to 2:00 PM the following Sunday. Even years - none.

- E. Mother's Day/Father's Day: To be spent with the parent being honored by the holiday in question from 10:00 AM to 7:00 PM.
- F. Birthdays: The child shall celebrate his or her birthday in the home of the custodial parent, unless the birthday falls on a regularly-scheduled visitation date with the non-custodial parent.
- G. Non-specified Holidays: Should the parents jointly recognize a holiday not specifically mentioned in this Order, each parent shall cooperate with the other in providing visitation with the non-custodial parent for the entire holiday on even-numbered years, and in working out beginning and ending times for such visitation

Child Custody and Visitation Requirements (Out-of-State Parent) continued

3. <u>VACATION FOR CHILD NOT ENROLLED IN SCHOOL</u>: Non-custodial parent- one month each year, to coincide with the non-custodial parent's vacation from his or her employment. Notice of the dates of such vacation period shall be given to the custodial parent no less than 60 days before the one-month visitation begins. The vacation visitation will last 30 consecutive days, and may not be "split" into lesser blocks of time unless both parties agree.

4. SUMMER VACATION FOR CHILD ENROLLED IN SCHOOL:

Non-custodial parent: from 5:00 PM on the second Friday after the end of the school year, to 5:00 PM on the eighth Sunday following the conclusion of the school year.

Custodial parent: one weekend visitation during the child's summer vacation with the non-custodial parent, from 5:00 PM on the fifth Friday after conclusion of the school year, to 7:00 PM on the following Sunday.

- A. Summer School: If the child is required to attend Summer School to pass to the next grade, it must be attended, and the above-described Summer Vacation Visitation Schedule does not apply. Weekend Visitation as set forth in Paragraph of 1 of this Order will apply during Summer School. The non-custodial parent's summer vacation visitation will commence at 5:00 PM on the Friday following the conclusion of Summer School, and last to 7:00 PM on the seventh Sunday following the conclusion of Summer School or 7:00 PM on the Sunday immediately prior to commencement of the new school year, whichever comes first.

Failure to properly provide for care and supervision of the child under such circumstances may result in loss of future visitation rights.
