Palm Beach County Leads the State with Judicial E-Filings

The Fifteenth Judicial Circuit Judges are moving away from paper orders faster than anyone else in the state, according to the Florida Courts E-Filing Authority. The Judges electronically filed 8,501 documents in December, far more than the triple-digit offering of more populous Broward and Miami-Dade counties and thousands more than the next-biggest adopter in the state.

The Court is making use of a judicial viewer built by the Circuit's technology team. The viewer aggregates information from the Sheriff, Clerk's Office, and others, providing a simplified dashboard for easy inspection. It also allows Judges to electronically view, sign, and file documents. The push for attorneys to submit proposed orders by computer so that a Judge can electronically sign and distribute them, is part of a statewide initiative to save time, money, and paper.



JUDGE AMY SMITH RETIRES

The Honorable Amy Smith, Circuit Judge, retired March 31, 2016 after serving the citizens of Palm Beach County for twelve years. Judge Smith was appointed to the Circuit bench on November 2, 2004, by Governor Jeb Bush

Judge Smith began her career in 1987 as an Assistant State Attorney in Palm Beach County. She then worked as a senior partner at the law firm of Walton, Lantaff, Schroeder, and Carson, LLP from 1989 until she was elected to the Circuit court in 2004

She obtained her B.A. degree from Mercer University, attended the University of Florida for her graduate studies in Education, and received her Juris Doctorate from Nova Southeastern University School of Law.

As a Circuit Judge, Judge Smith served in many divisions of the Court in the South, North, and Main Courthouses.

Chief Justice Jorge Labarga

In 2014, Justice Jorge Labarga became the first Cuban American selected by the Justices to serve as the Chief Justice of the Florida Supreme Court. In 2016, the Justices selected Chief Justice Labarga to serve a second two-year term beginning July 1, 2016. He is the 56th Chief Justice of the Florida Supreme Court.

Chief Justice Jorge Labarga graduated from Forest Hill High School, West Palm Beach, Florida. In 1976 he earned his Bachelor's Degree in political science from the University of Florida, Gainesville. He also obtained his Juris Doctorate from the University of Florida in 1979.

Prior to his appointment by Governor Crist to the Fourth District Court of Appeal and then to the Florida Supreme Court, Chief Justice Labarga served as a trial Judge in the Fifteenth Judicial Circuit where he presided over civil, family, and criminal cases.
