### Investiture of the Hon. Santo DiGangi





On May 10, the Circuit held the investiture ceremony for the Hon. Santo DiGangi, who was appointed to the County Court bench by Governor DeSantis. Judge DiGangi served as a staff attorney in the Circuit from 2009 to 2011. During the well-attended ceremony, many colleagues, family members, and friends presented gifts and spoke highly of Judge DiGangi's personality, community involvement and work ethic, as well as his love for his family.



Construction was recently completed on the 4th floor of the Main Courthouse, Juvenile Wing. At the request of Administrative Judge, Kathleen Kroll, and at least two Chief Judges (including Chief Judge Kelley), the County renovated space greatly improves the juvenile facilities. The renovation offers secure space, larger hearing rooms, and updated technology for use by the juvenile magistrate, senior judges, and court administration staff of the juvenile division. The juvenile magistrate uses one hearing room to preside over Review Hearings, while the other hearing room is available for TPRs and other court events. The space includes attorney/client rooms and a child-friendly room. The completed buildout comes years after its initial request because construction was stalled, in part, due to COVID closures and post-COVID supply chain delays. With this improved addition in the Juvenile wing of the Main Courthouse, the juvenile judges, magistrates, and court staff, can more effectively address challenges that impact children and families in our community.
